The composition of the membrane conforms to European legislation (CMR content cat. 1 and 2 less than 0.1% - Sum of Pb, Cd, Hg, Cr (IV) and As less than 100 mg/kg).

Storage Conditions: The rolls must be stored horizontally in their original packaging in a dry room at a moderate ambient temperature (15 – 25 °C).

Roll width should never be checked on the same roll, as the winding tension can cause variations. The roll width should be checked on the table with the material relaxed, at least one hour after its extension.
